Welcome to the EFRC Shop! EFRC provides its services to you subject to the following conditions. If you visit or shop within this website, you accept these conditions. Please read them carefully. CONCLUSION OF CONTRACTS/MEMBERSHIP

1. By ticking the button "Place Order" you place a binding offer for purchase of the chosen products/services. Our confirmation that your chosen product/service has been "added to your cart" approves that your order has been accepted by us.
2. You are obliged to truthfully complete the fields under "Billing details". Immediately after payment has been processed, the contract is deemed to be concluded respectively your membership fee is deemed to be paid.
3. The rights and obligations linked to the EFRC membership and participation in EFRC working groups, as have been agreed by all members through accession to EFRC, are stipulated in our respective Statutes and Resolutions.

AVAILABILITY OF PRODUCTS/SERVICES

1. In case the product/services will not be available short-time when you order it, we will let you know about this circumstance. To the extent the products/services will not be available permanently we will inform you about this, and refuse conclusion of a contract. Payments already made will be returned.
2. If at the point in time of your incoming order there is only a smaller number of products/services available than ordered, we will inform you about it. PAYMENT

RIGHT TO WITHDRAW FROM A CONTRACT

1. You have the right to withdraw from the contract within 14 days without giving reasons. The cancellation period starts 14 days from the date when the product/service has been delivered. This applies to all our products/services except for digital products/services which have been downloaded.
2. To execute your right to withdraw from the contract you have to inform us about your intention in writing (via mail or post). In order to comply with the cancellation period it will be sufficient if you will submit your withdrawal notice before expiration of the above mentioned period to :
